BACKGROUND:

The California Energy Commission's School Bus Replacement Program provides grant funding to public school districts and county offices of education to replace old diesel school buses. The program will award \$78.7 million in grant funds for buses with priority given to disadvantaged communities and schools with a majority of students eligible for free/reduced price meals (FRPM). The funding for the program

Funding from the program covers the full purchase of new electrical school buses, including taxes, up to \$60,000 per bus for electrical vehicle infrastructure, and workforce training and development resources to support maintenance and operation of electric school buses.

Application deadline is 5:00 pm on Thursday, September 20, 2018.
